RE: Power and Receptacles for Venders at Warrenton City Park-revised

Thank you for the opportunity to bid this project. The following items/scope of work will be provided:

- 1. Coordinate Excavation for site work.
- 2. Provide and install PVC conduit from Snack Shack to (2) receptacle locations.
- 3. Set treated post at receptacle location with PVC junction boxes and terminate underground conduit to each junction box.
- 4. Penetrate Snack Shack with underground conduit and terminate to electrical panel.
- 5. Provide and install (6) 50-amp feeders panel to receptacle locations.
- 6. Provide and install (6) 50-amp, 4-wire receptacles with weather proof covers at junction box locations.
- 7. Provide and install required breakers and make all terminations.
- 8. Provide (2) 50-amp "Spider Boxes".

Total cost of the above project

- 9. Provide (2) 50-amp power cords to feed "Spider Boxes".
- 10. Provide Clatsop County Electrical Permit.
